## **OLD BUSINESS**

### **DEPARTMENT FORUM**

#### **A. Veterans Employment Update**

Deputy Albertson briefed the Board on the latest efforts to overcome the stigmas associated with hiring Vets, and working with employers to create opportunities to re-tool Veterans and re-engage them in employment. They are also concerned about returning Vets being re-integrated into the training pipeline utilizing the 911 G.I. Bill.

#### **B. Homes Update**

Robin Umberg updated the Board on:

- the census of the Homes, and exploring opportunities to utilize the rooms for students
- moving forward to synchronize the pharmacy program
- the six month delay of the Fresno and Redding Homes resulting in an opening date of January 2013
- the need for a medical marijuana policy
- a resident benefit package for discussion at the next meeting

#### **B. Review of Board Policies**

##### C-2 – Disqualifying Conditions for Admission to the Veterans Homes

The language regarding the admission of applicants with criminal histories was discussed, and will be revised for better clarification. Legal Counsel will review, and a draft of C-2 will be presented at the October meeting for final approval. Also, “waiting for State statute” will be removed.

##### C-7 – Land Use

The Board made note that as stated in C-7, any plans for usage of the Homes or land, needs prior Board approval. The Policy Committee will add language to allow exceptions to avoid delays in negotiations or decisions. A draft will be presented for approval at the October meeting.

##### C-11 – Inter Facility Transfer Policy

Dr. Chong, recommended the language under 3(a) be revised, and it was agreed that this policy would be further reviewed, and tabled until the next meeting.

### **COMMENTS BY BOARD MEMBERS**

Member Richards reported that the recent San Diego Commander's Council meeting was very successful, and Secretary Gravett attended. He will circulate the legislative reports from the meeting. Deputy Secretary Veterans Services Trevor Albertson will attend the next Council meeting.
