SUBJECT: WINTER PROFESSIONAL TRAINING CONFERENCE (February 10 – 14, 2014)

The California Department of Veterans Affairs (CalVet) is sanctioning the Winter Professional Training Conference.

California Code of Regulations Title 12, Chapter 3, Subchapter 4, Section 453 designates \$2,500 in State Subvention funds and Section 453.1 designates \$1,500 from the Veterans Service Office Fund (VSOFF) to offset the cost of attending the CalVet sanctioned training conference as follows:

Starting: Monday, February 10, 2014
Continuing: Tuesday, February 11 - Wednesday, February 12 - Thursday, February 13
Ending: Friday, February 14, 2014

CalVet is sanctioning the entire week; however, in order to obtain funding, your county must be represented **on Tuesday the 11th, Wednesday the 12th and Thursday the 13th in order to obtain funding.**

Failure to attend will result in a reduction in your 2013/2014 State Subvention in the amount of \$833 and \$500 under the Special Fund-VSOFF.
