SUBJECT: SPRING PROFESSIONAL TRAINING CONFERENCE (May 4 – 9, 2014)

The California Department of Veterans Affairs (CalVet) is sanctioning the Spring Professional Training Conference per California Code of Regulations (CCR) Title 12, Chapter 3, Subchapter 4, Section 453.

During Fiscal Year 2013/2014, CCR designates \$2,500 in State Subvention funds and \$1,500 from the Veterans Service Office Fund (VSOF) to offset the cost of attending the CalVet sanctioned trainings. The Spring Training Conference is scheduled as follows:

Starting: Monday, May 5, 2014  
Continuing: Tuesday, May 6 - Wednesday, May 7 - Thursday, May 8  
Ending: Friday, May 9, 2014

CalVet is sanctioning the entire week; however, in order to obtain funding, your county must be represented **on Tuesday the 6th, Wednesday the 7<sup>th</sup> and Thursday the 8<sup>th</sup> in order to obtain funding.**

Failure to attend the Spring Training Conference will result in a reduction in your 2013/2014 State Subvention in the amount of \$833 and \$500 under the Special Fund-VSOF.
