INSTRUCTIONS FOR THE
SEMI-ANNUAL REPORT
DVS 16

The DVS 16 is utilized by all County Veterans Service Officers for the purpose of reporting awards and activities data to the California Department of Veterans Affairs. The data inserted on the DVS 16 should reflect the accumulated six (6) month totals for the appropriate reporting period and is derived from the DVS 19 (Daily Activity Report), DVS 20 (Subvention Awards Register) and the DVS 20MC (Medi-Cal Cost Avoidance Awards Register).

Submit the DVS 16 no later than 30 days following the end of the six (6) month reporting period:

For the six month period commencing July 1st and ending December 31st, the DVS 16 is due by January 31st.

For the six month period commencing January 1st and ending June 30th, the DVS 16 is due by July 31st.
